1. Foreign residents or companies of another State qualify to hold ownership of a vessel registered in San Marino after electing domicile with an agent residing or legally established in San Marino.
2. This application must be signed by the beneficial owner, company director, or authorised representative holding a power of attorney.
3. The nominated resident agent will act as the representative of the owner for all necessary correspondence for the registration of the ship and any other services necessary for flying the San Marino Flag in accordance with the Maritime Authority of San Marino laws and regulation. The resident agent will be responsible to transmit to the owner any notifications from the SM MNA.
4. Should the resident agent resign from this position, the SM MNA shall be informed immediately. The Certificate of Registry could be revoked if an application nominating a new representative is not submitted by the registered owner.
