Guidance Notes for the Completion of this Application

- 1. This form is the document, which is recorded within the MNA SMR Register of Ships and therefore should reflect exactly the same details as described within the mortgage agreement.
- 2. This form must be completed and signed by the mortgagee.
- 3. This form should be accompanied by the mortgage agreement with the requested formalities (notarization of signature and apostille) and appropriate fee. In order to proceed with the Mortgage registration, a scan copy of mortgage agreement duly notarized is required. Then our Authority allows 60 days from the date of the mortgage registration to send via courier to SM MNA office the original mortgage agreement already notarized also apostilled, with attached also original Form SM 14. Find below an example of an acceptable statement of notarization of the signature by a notary, we highly suggest you to use such draft if possible:

- 6. If the application is acceptable, the MNA SMR shall proceed to the relevant registration and shall notify the parties thereof.
